UPON ARRIVING ON SCENE, OFFICERS MET WITH COMPLAINANT TRACEY GLAWE WHO IS A WORKER FOR AT&T WHO HAD RENTED THIS RESIDENCE TO HOUSE CLIENTS FOR THE MASTER'S GOLF TOURNAMENT. TRACEY STATED THAT SHE HAD SECURITY CAMERA FOOTAGE OF

A WHITE MALE ARRIVING AT THE RESIDENCE IN A BLACK MERCEDES SEDAN. THE MALE WAS WEARING GLASSES, A WHITE HAT WITH A BLACK BILL, A GREEN MASTER'S SWEATSHIRT, KHAKI SHORTS. THE MALE ALSO APPEARED TO BE WEARING A GLOVE ON HIS RIGHT HAND. THE FOOTAGE SHOWED THE MALE WALKING THROUGH THE BACKYARD THROUGH A GATE, THEN ENTERING THE RESIDENCE THROUGH THE BACK DOOR. TRACEY ALSO PROVIDED A PHOTO OF THE MALE WALKING BACK TO HIS CAR WITH TWO MASTER'S BAGS IN HIS LEFT HAND. THE STOLEN PROPERTY CONSISTED OF MASTER'S GOLF TOURNAMENT GIFT SHOP MEMORABILIA INCLUDING A CUSTOM MASTER'S BAG, 1 LARGE GARDEN GNOME, 2 SMALL GARDEN GNOMES, AND A MASTER'S GIFT SHOP SHOPPING BAG, ALL CONTENTS TOGETHER VALUING AT APPROXIMATELY \$200. EMPLOYEES STATED THAT THIS PROPERTY BELONGED TO JOHN STANKEY WHO IS THE CEO OF THE COMPANY, AND THAT THEY DID NOT WANT TO PRESS CHARGES FOR THE LARCENY. THE EMPLOYEES REFUSED TO PROVIDE ANY CONTACT INFORMATION FOR MR. STANKEY FOR A DECLINE TO PROSECUTE FORM. THERE WERE NO SIGNS OF FORCED ENTRY ON EITHER THE BACKYARD GATE, OR THE BACK DOOR TO THE RESIDENCE WHICH LED OFFICERS TO BELIEVE THAT THE BACK DOOR WAS UNLOCKED, BUT THE COMPLAINANT AND OTHER WORKERS STATED THAT THEY DID NOT KNOW THE MAN AND THE COMPLAINANT CONFIRMED WITH THE HOMEOWNER VIA PHONE CALL THAT HE HAD NO RIGHT TO BE THERE. THE COMPLAINANT WAS ABLE TO PROVIDE A NAME AND PHONE NUMBER OF THE HOMEOWNER (CHRISTINE ODEN 765-506-4190) BUT NOT ANY FURTHER PERSONAL INFORMATION, SO OFFICERS WILL CONTACT THE HOMEOWNER AT A REASONABLE HOUR TO OBTAIN MORE INFORMATION. THE COMPLAINANT EMAILED OFFICERS THE SECURITY CAMERA FOOTAGE AND PHOTOS, THEY WILL BE ATTACHED TO THIS REPORT. PSO LYKINS COMPLETED A REPORT FOR DOCUMENTATION. NO FURTHER INFORMATION AT THIS TIME.

ON APRIL 13, 2026, AT APPROXIMATELY 1800 HOURS, PSO LYKINS CONTACTED THE ORIGINAL COMPLAINANT TRACEY GLAWE TO ASK ABOUT A DOCUMENT THAT WAS SENT IN VIA EMAIL. THIS EMAIL LISTED SEVERAL OTHER ITEMS THAT WERE DISCOVERED MISSING AFTER THE RESPONDING OFFICERS LEFT THE SCENE FROM THE INITIAL INVESTIGATION. PSO LYKINS SPOKE WITH TRACEY GLAWE WHO RE-SENT THE DOCUMENT WITH ESTIMATED VALUES OF EACH PIECE OF PROPERTY AND STATED THAT THE TOTAL VALUE OF ALL THE PROPERTY TOTALED WELL OVER \$1000. PSO LYKINS UPLOADED THIS UPDATED INFORMATION INTO EVIDENCE AND ATTACHED THE PROPERTY TO THE REPORT. SHORTLY AFTER, PSO LYKINS WAS ABLE TO GET IN CONTACT WITH THE HOMEOWNER AT 172 E SHORELINE DRIVE AND OBTAINED FURTHER PERSONAL INFORMATION THAT OFFICERS WERE UNABLE TO OBTAIN AT THE SCENE DURING THE INITIAL INVESTIGATION DUE TO HER ABSENCE, AND INCLUDED IT INTO THE INCIDENT REPORT. THE HOMEOWNER (CHRISTINE ODEN), OVER THE PHONE WAS ADAMANT ABOUT PRESSING CHARGES ON THE SUBJECT FOR THE UNLAWFUL ENTRY. No further information was provided.




