UPON ARRIVAL R/O MET WITH OLIVER JONES WHO IS THE VICTIM TO THIS INCIDENT. JONES ADVISED R/O IN HIS WRITTEN STATEMENT THAT HIS 2007 INFINITI QX56 BEARING SOUTH CAROLINA TAG OF PZB716 WAS ENTERED INTO WITHOUT HIS PERMISSION LAST NIGHT BETWEEN THE HOURS OF 2200 ON 0/04/2018 AND 1000 HRS ON 08/05/2018. JONES ADVISED R/O THAT THE VEHICLE WAS LEFT UNLOCKED LAST NIGHT AND THAT THERE WAS NO FORCED ENTRY INTO HIS VEHICLE. JONES ADVISED R/O THAT HE WALKED OUT TO HIS VEHICLE AT APPROXIMATELY 1000 HRS TO FIND THAT THE DRIVER SIDE DOOR AND THE PASSENGER SIDE DOOR WERE LEFT OPEN FROM THE INCIDENT. JONES ADVISED R/O THAT THERE WAS A STATEFARM CHECK VALUED AT \$7,000.00 THAT WAS MISSING FROM HIS VEHICLE. JONES ALSO ADVISED THAT \$50.00 IN CASH WERE ALSO MISSING FROM HIS VEHICLE. R/O WAS UNABLE TO LOCATE ANY VIABLE FINGERPRINTS TO OBTAIN FOR EVIDENCE IN RELATION TO THIS INCIDENT. JONES WAS ABLE TO MAKE CONTACT WITH STATEFARM IN REFERENCE TO THE CHECK. STATEFARM WAS ABLE TO PLACE A STOP PAYMENT ON THIS CHECK. THERE ARE NO CAMERAS AROUND THE VEHICLE TO OBTAIN FOOTAGE OF THE INCIDENT.
