SHE STATED THAT SHE LEFT HER VEHICLE UNLOCKED AND PARKED ON THE ROAD IN FRONT OF HER RESIDENCE. SHE FOUND THAT SOMETIME IN THE NIGHT HER VEHICLE HAD BEEN GONE THROUGH.
