STATED THAT SHE HAS NO IDEA WHO MAY HAVE STOLEN THE ELECTRIC VEHICLE, BUT THAT THERE ARE MORE STRANGERS IN THE AREA LATELY DUE TO CONSTRUCTION IN THE AREA. STATED THAT THE VEHICLE REQUIRES KEYS TO OPERATE, AND THAT WHOEVER STOLE IT MUST HAVE HOT-WIRED IT.
