MR. GODWIN STATED THAT HIS WHITE IN COLOR 2012 CHEVROLET AVALANCHE WAS LOCKED ON THE EVENING OF 08/04/2018 WHEN HE EXITED IT. MR. GODWIN STATED THAT HE DISCOVERED THAT A GRAY IN COLOR PEOPLE'S BANK DEPOSIT BAG AND HIS BROWN IN COLOR WALLET WERE MISSING FROM BESIDE HIS DRIVER'S SEAT. MR. GODWIN STATED THAT THE BANK DEPOSIT BAG CONTAINED 4 CHECK BOOKS; HIS PERSONAL FIRST CITIZEN'S CHECKING ACCOUNT BOOK, HIS WIFE'S PERSONAL FIRST CITIZEN'S CHECKING ACCOUNT BOOK, HIS MOTHER'S

PERSONAL SRP CHECKING ACCOUNT BOOK, AND HIS COMPANY CHECK BOOK (TRANSCO). MR. GODWIN STATED THAT THE BANK DEPOSIT BAG ALSO CONTAINED APPROXIMATELY \$600.00 US CURRENCY. MR. GODWIN STATED THAT HIS WALLET CONTAINED HIS SOUTH CAROLINA DRIVER'S LICENSE, FIRST CITIZEN'S AND SRP BANK CARDS, HIS SOCIAL SECURITY CARD, AN AMERICAN EXPRESS CREDIT CARD, AND AN AMERITRADE STOCK MARKET CARD. MR. GODWIN STATED THAT THE BANK DEPOSIT BAG WAS LEFT IN HIS VEHICLE DUE TO A BUSINESS TRIP FROM WHICH HE HAD RECENTLY RETURNED AND HIS WALLET WAS LEFT AS HE WENT TO A POOL. MR. GODWIN STATED THAT HE WOULD HAVE HIS BANK/CREDIT CARDS CANCELED AND WOULD MONITOR THE ACCOUNTS IN QUESTION.

R/O OBSERVED THAT THE REAR DRIVER SIDE DOOR HANDLE OF MR. GODWIN'S VEHICLE WAS PARTIALLY TORN OFF AND THAT THE FRONT PASSENGER SIDE DOOR HANDLE WAS BROKEN. R/O CHECKED THE FINISH OF THE DOOR HANDLES, WHICH WERE SHINY SILVER, AND OBSERVED NO FINGERPRINTS. R/O DETERMINED THAT THE SUBJECT(S) WERE LIKELY WEARING GLOVES. R/O SEARCHED THE E SHORELINE DRIVE AND LANDING DRIVE AREAS AND DID NOT LOCATE ANY DISCARDED BELONGINGS. R/O OBSERVED WHAT APPEARED TO BE BICYCLE TRACKS IN THE GRASS AT THE EAST END OF E SHORELINE DRIVE THAT LED INTO THE WOODS. R/O DID NOT LOCATE ANY BICYCLES AND COULD NOT DETERMINE WHETHER OR NOT THEY WERE RELATED TO THIS INCIDENT. R/O HAS NO FURTHER.
